

## LONGSCAN & NEGLECT Publications

**LONGSCAN (L)** = A publication that uses LONGSCAN data or that used LONGSCAN funds/resources/salary support in development.

**NEGLECT (N)** = A publication that uses NEGLECT data or that used NEGLECT funds/resources/salary support in development.

**ARCHIVE (A)** = A publication that uses data from one of the LONGSCAN datasets archived at the National Data Archive on Child Abuse and Neglect (NDACAN).

**Adolescent Pregnancy & Birth Outcomes Among Maltreated Youth (COL)** = A publication that uses LONGSCAN data with analysis support coming from this adjunct project funded by the CDC.

**LONGSCAN or NEGLECT-Related (R)** = A publication that is related to an investigator's work on LONGSCAN or NEGLECT; however is not a direct LONGSCAN/NEGLECT product/effort. A publication that is informed significantly by LONGSCAN or NEGLECT; or on which salary support was partially provided from LONGSCAN or NEGLECT funding.
